- 3. The Punjab Civil Services Rules (General and Common Conditions of Service Rules) 1994 have been applicable w.e.f. 04.05.1994. As per rule 18(2), if any Govt. employee refuses to accept promotion, he shall be debarred by the appointing authority from consideration for promotion for all the consecutive chances, which may occur in future within a period of two years from the date such refusal to accept promotion.
- 4. The Head of the concerned district will ensure that the officials approved for promotion are relieved immediately or alternatively they should get in writing within 30 days from such officials that they want to forgo their promotion. This order will further be subject to final decision of CWP/SLP (if any) pending in the Hon'ble High/Supreme Court of India regarding seniority etc.
